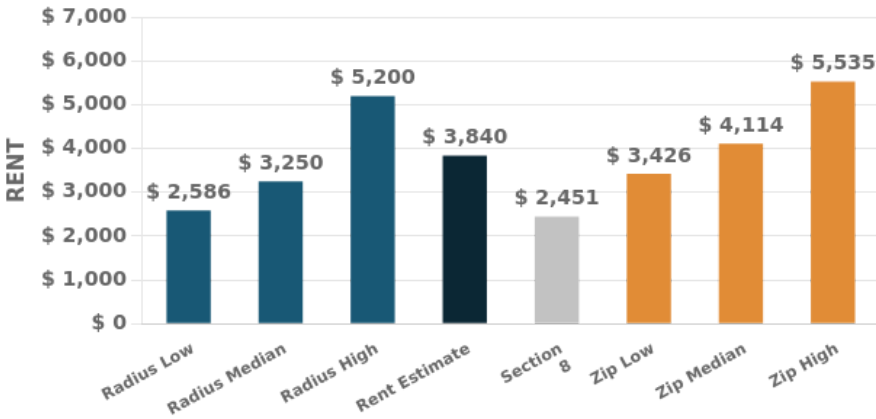

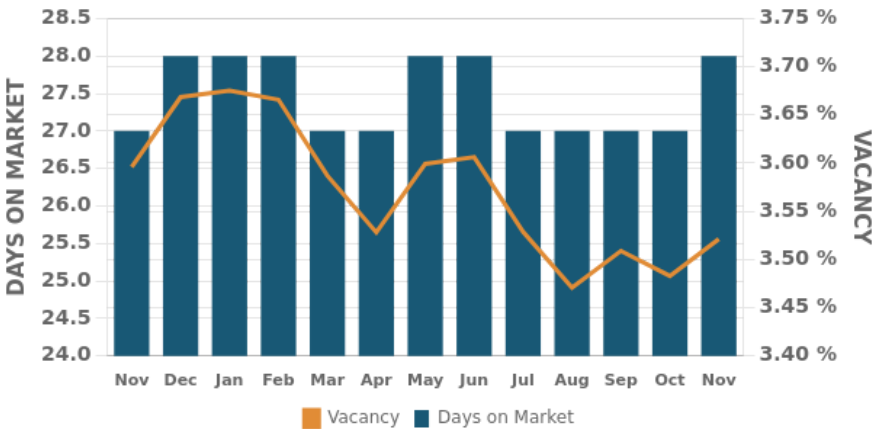

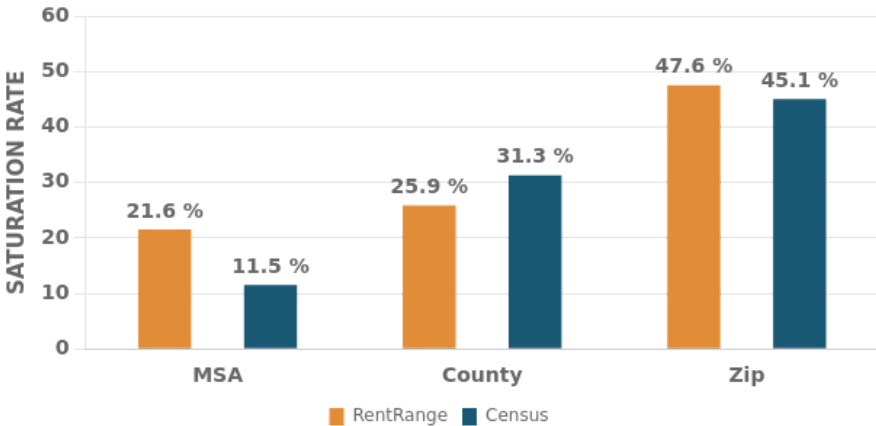

RENTAL SATURATION BENCHMARKS



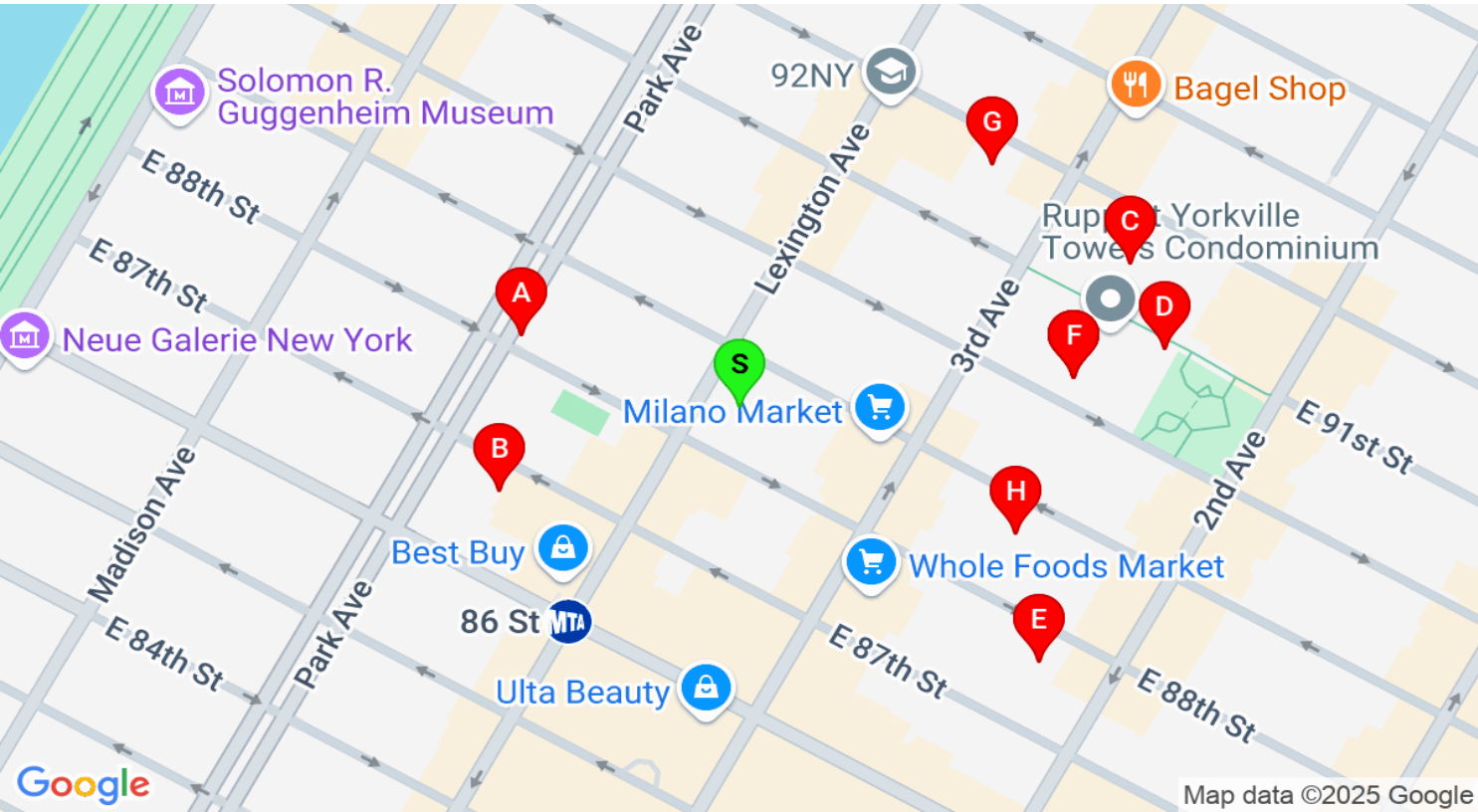

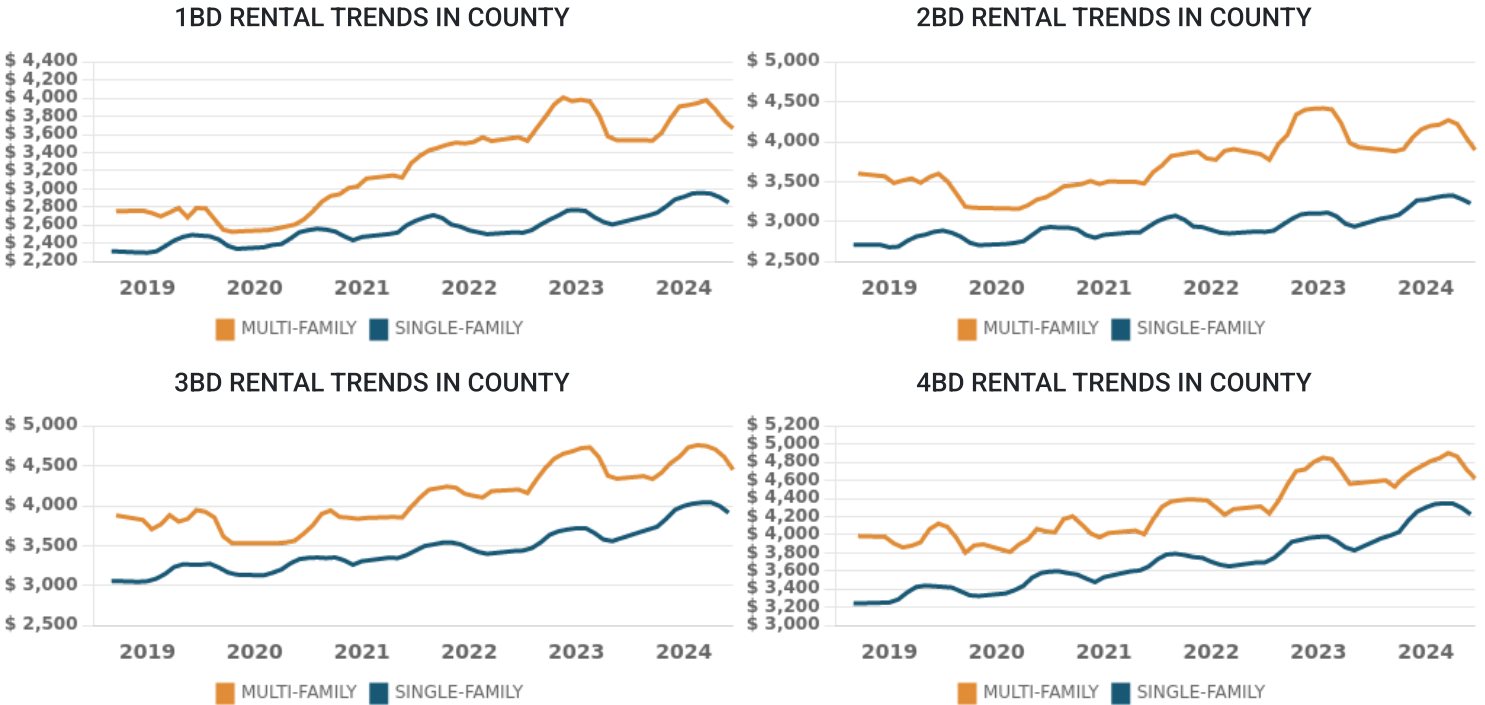

| <b>CENSUS COUNTRY SATURATION</b>                  | Estimated percentage of renter-occupied units versus owner-occupied units as reported by U.S. Census / American Community Survey within the geography searched.
