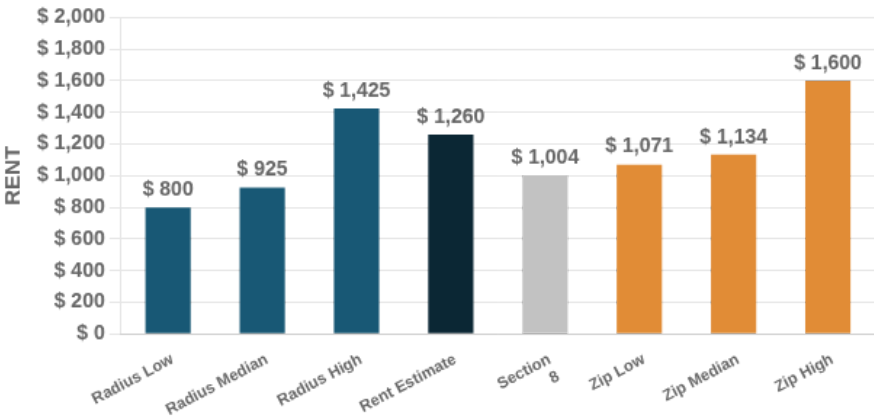

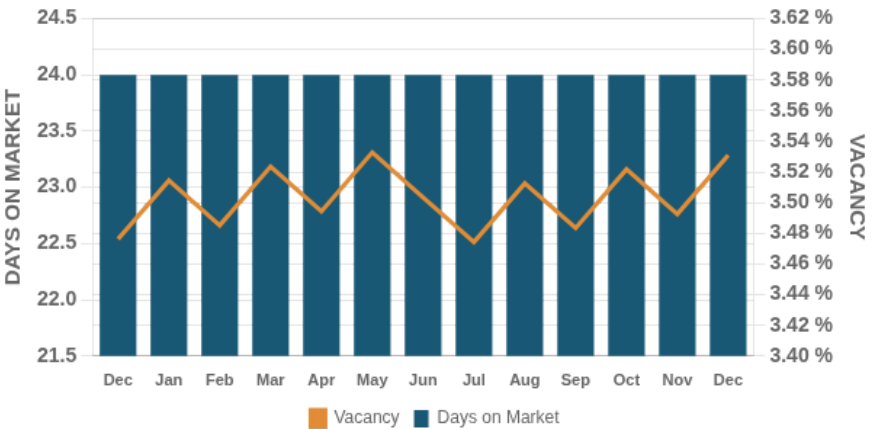

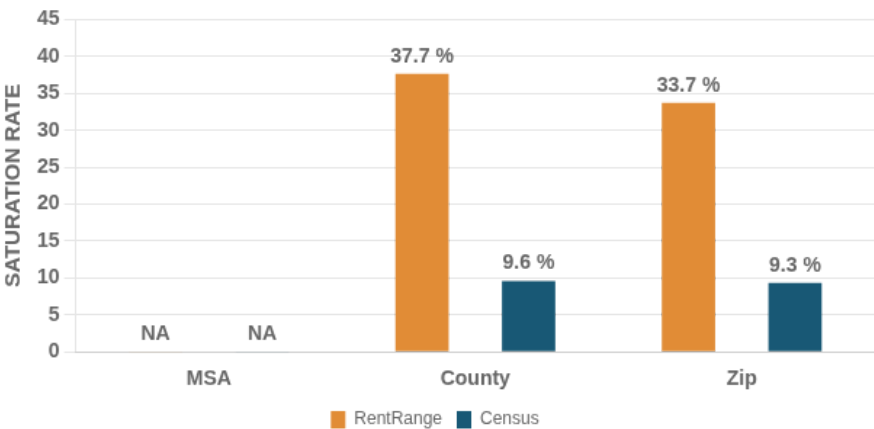

RENTAL SATURATION BENCHMARKS



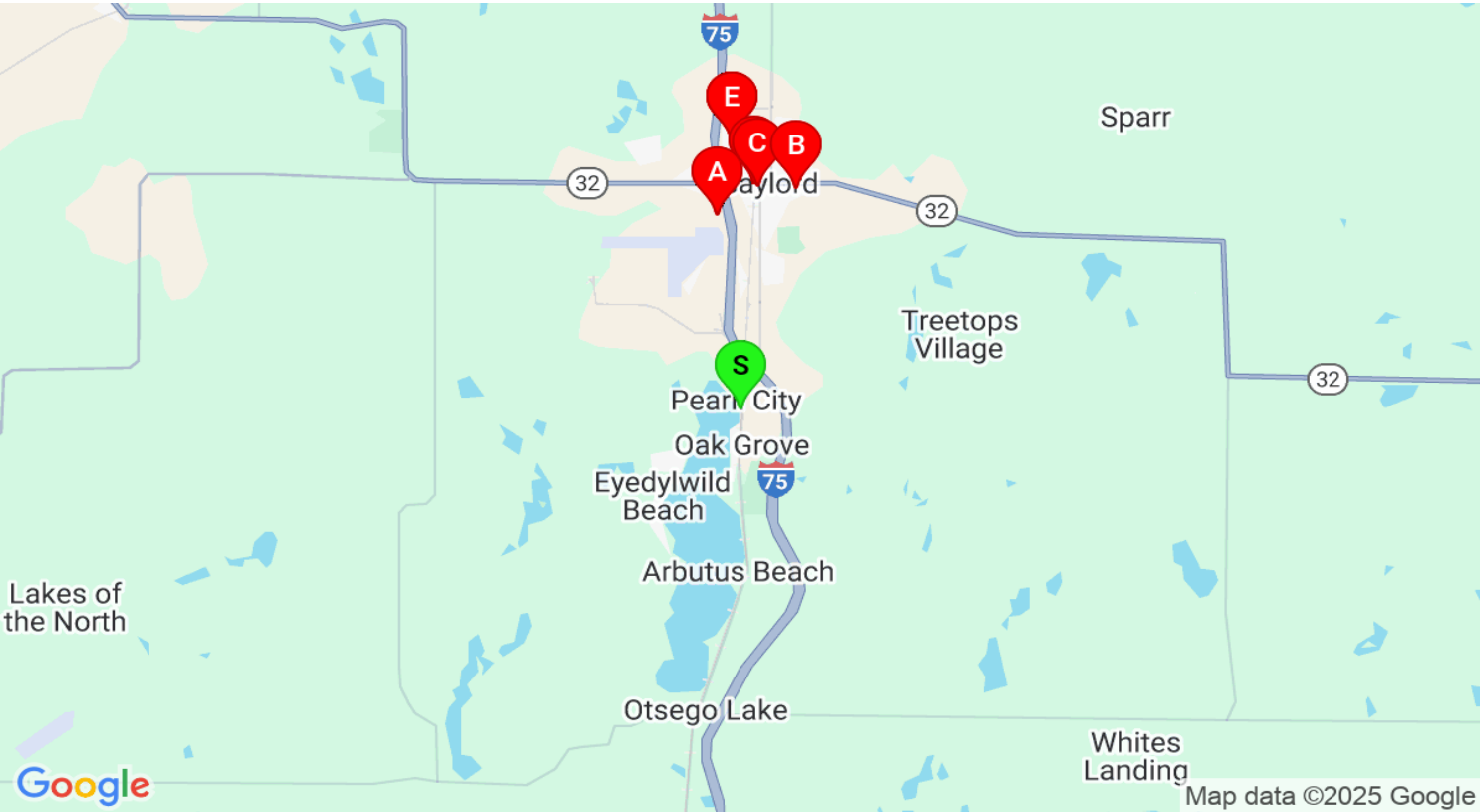

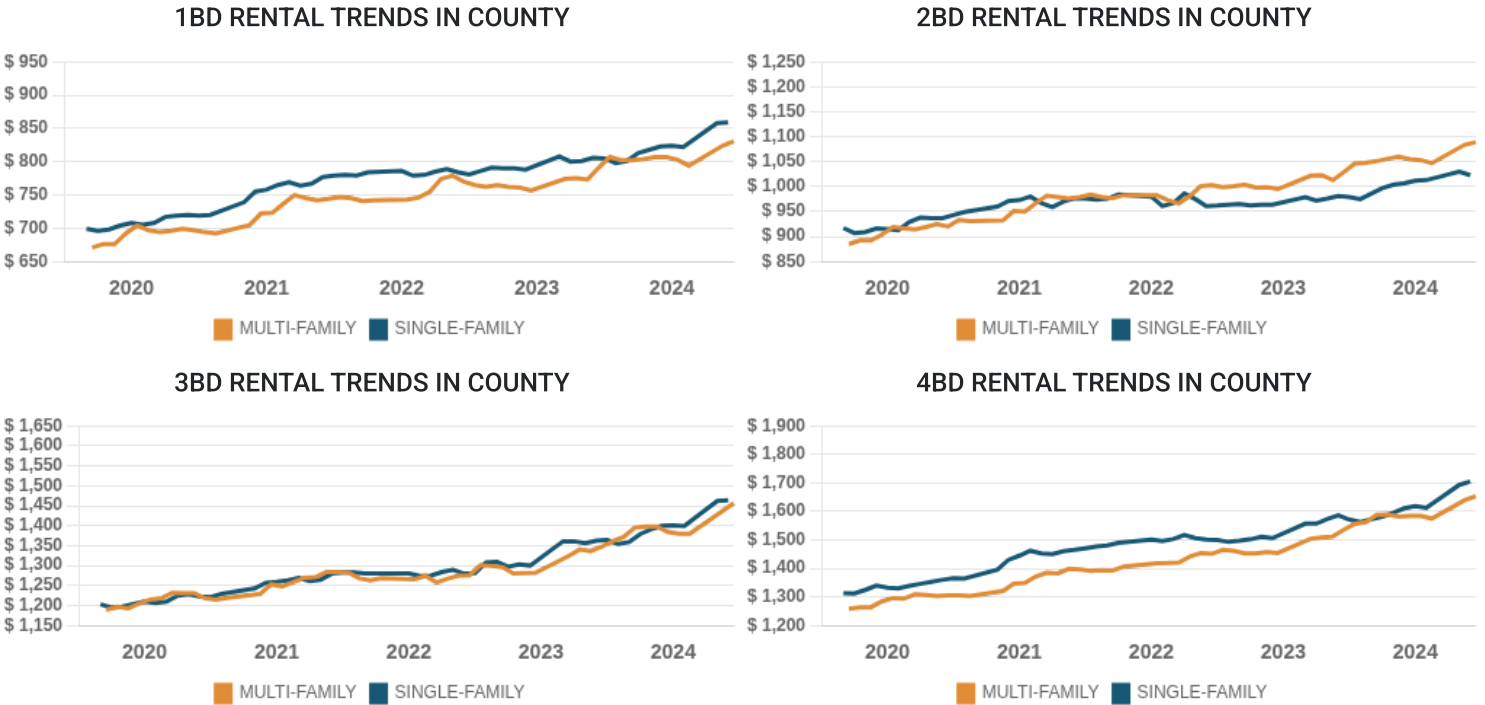
